On September 13, 2013, Ahorner Holding GmbH, Salzburg, Österreich has informed us according to Article 21, Section 1 of the WpHG that via shares its Voting Rights on Porsche Automobil Holding SE, Stuttgart, Deutschland, have exceeded the 3%, 5%, 10%, 15%, 20%, 25%, 30%, 50% and 75% threshold of the Voting Rights on September 11, 2013 and on that day amounted to 98.40% (this corresponds to 150671400 Voting Rights).

According to Article 22, Section 1, Sentence 1, No. 1 of the WpHG, 2.70% of the Voting Rights (this corresponds to 4137393 Voting Rights) is to be attributed to the company.
